## CHAIRMAN'S REPORT 2022 (AGM: Pat Yaxley)

We are all very grateful to those concerned: Mrs Dhala herself, Dr Ibrahim and her daughter and Dr Rijal. They did an absolutely superb job of both initiatives.

It would be invidious of me to report on the year without recording the impact on TWC of the sudden deaths of Peter Gammage and Antonia Derry. As you know, Peter was in regular attendance at AGMs in the last few years, always ready to show photographs or videos from Mumbai etc. as well as keeping our website up to date. As for Antonia, I cannot begin to count how many times, in the last year, I've thought "Antonia would have known about this or that" or "Antonia would/would not have approved" etc. etc. Our deepest sympathy goes to their families and to all the families who have lost loved ones during the year.

To conclude, I think that out of the negatives of 2020 have arisen, pheonix-like, some positives – and ideas of how to move forward using the knowledge that we've gained.

Not only that but this brute of a year has shown us all that women of different nationalities, different outlooks, different priorities can all come together and work as an effective team and it has been a privilege to be part of it.
